Subject: Report.

Sir,

I am writing to report that I am a resident of Khuga Tampak Meitei Leikai, Churachandpur District and running a Salon by the name A.A. Creative Salon (Anand & Anita) at old Bazar Super Market, Churachandpur which was rented from one Namkhanthang Valte of Zenhang Lamka, Churachandpur.

That self and my family members are victims of the present unrest that outbreaks from 3<sup>rd</sup> May, 2023.

That, on 7<sup>th</sup> May, 2023 at around 4.00 pm while my family was at Mini Secretariate, Tuibong, I recieved a phone call from one of my Kuki customer namely Richard (full particular not known) stating that my salon had been vandalised and all the properties inside of it were looted after breaking the lock & key of the Salon by unknown miscreants suspected to be of kuki militants. The approximate amount of the damaged & looted items is worth around Rs 1,39,000/- (rupees one lakh thirty nine thousand) only in the present market.

I Could not report well in time as my family were stranded & displaced which later took shelter at relief camp at Old DC Complex Bishnupur. And further self & wife were attended to medical treatment of father-in-law at JNIMS, Imphal. And on 8<sup>th</sup> of Sept, 2023 we were returned to relief camp at Old DC Complex Bishnupur.

It is therefore, requested kindly to take up necessary action against the unknown miscreants suspected to be of kuki militants.
