

Subject: Report.

Sir,

I am writing to report that I lived in a rented house of one Thangboi Haokip of Molnom Saron Veng, Churachandpur District and running a Mechanic Workshop at his rented house.

That self and my family members are victims of the present unrest that outbreaks from 3rd May, 2023.

That on 4th May, 2023 at around 5.00 pm while my family was at relief Camp at Old DC complex, Bishnupur District, I received a phone call from one Thangboi Haokip of Molnom Saron Veng, Churachandpur District (Land owner) stating that my rented house and Shop were had been vandalised and all the properties inside of it were looted after breaking the lock & key of the store by unknown miscreants suspected to be of kuki militants. The approximate amount of the damaged & looted items is worth around Rs. 62,23,000/- (rupees Sixty two Lakhs & Twenty Three Thousands) only in the present market.

I could not report well in time as my family were stranded & displaced which later took shelter at relief camp at Old DC complex, Bishnupur District. And further self attended to medical treatment of my Wife at JNIMS, Imphal. And on 15th of Sept, 2023 we were returned to relief camp at Old DC complex, Bishnupur District.

It is therefore, requested kindly to take up necessary action against the unknown miscreants suspected to be of kuki militants.
