

That, I am the owner of the homestead under patta No. 320 (new) covered by C.S. Dag No. 3171 measuring an area of 0.19 acre of village no. 9- Biyang (Tuibuong) within the Churachandpur District, Manipur. (Jamabandi copy is enclosed herewith). I have constructed one shop plot cum residential semi-pucca double storied building of CI-sheet roofing consisting 18 (eighteen) rooms upon the said land. My said building are occupying by different tenants since last many years.

That, on 08-05-2023, my said shop plot cum residential semi-pucca double storied building had been destroyed by unknown miscreants suspected to be Kuki-miscreants after looting all the articles kept inside the building.
