

Subject: Report.

Sir,



I the undersigned, have the honour to report you the following few lines for your kind and sympathetic action.

That, self and my father has been staying at the rented house of one Sang Lur aged about 75 years of Khupibung village, Churachandpur since past 10(ten) years looking after his paddy land located in the same village.

That, self also engaged in Tractor service such as Ploughing of paddy field and threshing of paddy using my own Tractor engine & paddy thresher machine when times permits me.

That, on 04/05/2023 at @ 4.30 am group of unknown persons suspected to be members of All Tribals Students Union, Manipur (ATSUM) along with Kuki militants with full arms numbering about 400-500 persons stormed at our location and started vandalizing & destroying house hold properties. The unknown miscreants forcibly took control and seized the above said machines and also looted other house hold items and later they burnt my kacha building to ashes. Further, they threatened us to leave the place immediately and not to return back again. So, self and my father ran towards DC complex Churachandpur. After staying nearly a week there, we were taken to Khuman Lampak by an Army convoy and then returned to home.

The details of the lost/destroyed items is worth approximately Rs.12,65,500/-(rupees twelve lakhs sixty-five thousand five hundred only) in the present market value. Also enclosed herewith as annexure-1.

It is therefore, requested kindly to take up necessary action against them & recover my lost tractor engine & paddy thresher.

I could not report well in time due to lack of legal awareness.

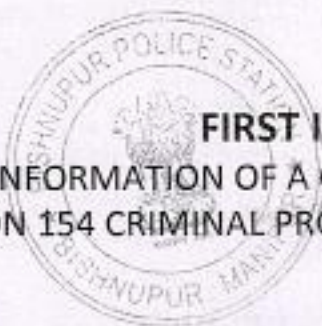
