


Subject : Report.

Sir,

I, the undersigned, have the honour to report you that on 03/05/2023 at about 4.50pm, a huge numbers of unknown persons suspected to be the members of All Tribal Students Union, Manipur (ATSUM) along with Kuki Militants with full arms numbering about 5000 came to our village and then they started to destroy the properties of the Meitei villagers and also burned down the houses and shops of the said Meitei people without any reasons. Further, they also loot the valuable items and taking out the same from my semi pucca house which was constructed my pattaland and other villagers forcibly and after completion of loot they burned down my said house. Immediately I along with my family members escaped from them without any giving objection to their illegal acts of the Kuki Tribes due to fear and panic. They also directed to me and my family members with a threat that to go and leave from my said house permanently otherwise I along with my family members shall face dire consequences. And as such, I along with my family members and some villagers of my locality run from there after leaving my valuable house whole articles, kitchen items, apparels, gold ornaments, commercial items, ducks, paddy bags, etc. amounting to altogether Rs. 18,04,000/- (Rupees Eighteen Lakhs Four Thousands) only due to fear and panic the illegal acts of the Kuki Tribes.

Unluckily, I could not report in timely to the concerned police station due to the prevailing situation of Manipur and I myself with my family members were displace and stranded, taking shelter at the Relief Camp, Mangolnganbi College, Ningthoukhong, Manipur.

In this regards, you are, therefore, request you kindly to take legal actions against the persons who acted illegally and punish them under the eye of law at the earliest.
