Sir.

I, the undersigned, have the honour to report you that on 03/05/2023 at about 2.00pm, a group of unknown persons suspected to be the members of All Tribal Students Union, Manipur (ATSUM) along with Kuki Militants with full arms numbering about 3000 came to our village and then they started to destroy the properties of the Meitei villagers and also burned down the houses and shops of the localities without any reasons. Further, they also loot the valuable items and taking out the same from my kutcha house and other villagers forcibly. They also burned down my kutcha house. They directed to me and my family members with a threat that to go and leave from my said kutcha house permanently otherwise I along with my family members shall face dire consequences. Immediately, I along with my family members and some villagers of my locality run from there after left my valuable house whole articles, kitchen items, apparels, gold ornaments, commercial items, hens, ducks, cows, paddy bags, Machinery items, cash etc. amounting to altogether Rs. 6,13,000/-(Rupees Six Lakhs Thirteen Thousands) only due to fear and panic the illegal acts of the Kuki Tribes.

Unluckily, I could not report in timely to the concerned police station due to the prevailing situation of Manipur and I myself with my family members were displace and stranded, taking shelter at the Relief Camp, Mangolnganbi College, Ningthoukhong, Manipur,

In this regards, you are, therefore, request you kindly to take legal actions against the persons who acted illegally and punish them under the eye of law at the earliest. Retreated as an O.E if case
