I the undersigned have the honour to state the following few lines before your for your kind consideration and sympathetic action

That, I am a resident of Tuibong Peace ground, Churachandpur having five family members comprises of self, my daughter in-law, grand son and two grand daughters. And my house is a kacha building, constructed on a patta land of one Laishram Ningthouren Singh(54) S/o.(L) L. Brajamohol Singh of Tuibong Peace Ground, Churachandpur.

That, on 3rd May, 2023 at @ 6.30 pm some armed/unarmed Kuki militants numbering around 100-200 stormed at my residence and started assaulting us. some other parties started vandalizing house hold properties. They threatened us to leave the premise immediately, also warned us not to come back again. So, my family ran towards a nearby field and hide there to save our life. Later my family stayed at DC Complex, Churachandpur.

During that time, it was learnt that my house hold properties were destroyed and the valuable items were also looted and later my house was bunt to ashes by the said miscreants. The total lost items is worth about Rs. 2,681,700.00/- Approximately(enclosed herewith as annexure).

It is therefore requested your goodself to take stunt action against the kuki militants at an earliest.

I could not report well in time due to present law and order situation as well my family was stranded & lost. Later arrived to Ngaikhong village i.e. at the parental house of my daughter in-law through Army convoy. And I was hospitalized at RIMS for about 3(three) months due to my heart problems in c/w the said incident. After all my daughter in law also conducted operation at SAIBO hospital, Kharai Lamlong due her uterus problem.
