


I have the honour to state that on 04/05/2023 at @ 8.10PM some unknown persons suspected to be Kuki's numbering about 70-80 persons having daos, Catapults and sword with full Arms dismantled my rent house staying since last 12 yrs situated at Churchandpur Old Bazar Ginsin Road, Churchandpur. Churchandpur District P.O/P.S – Churchandpur and in addition to this they also attack to us and burnt my rent house causing damage all my household property using deadly weapons.

As a result of which I along with my family members left the residential area and now staying at the Relief Camp, Laphupat Tera High School Govt. Aided Laphupat Tera. Due to the incident my household properties worth Rs.8,31,000 were damaged. We could not report the matter to Churchandpur Police Station due to the present Communal crisis.

You are therefore requested to take up the further necessary actions against the Culprits.





