

Subject: Report on House Building Vandalisation.

Sir,

I have the honour to state the following few lines for your kind consideration and taking further necessary action please.

That, I was displaced from my native village on 03/05/2025 due to the prevailing crisis and take refuge at Tangnuam Village. Whereas my House, Pucca Building built recently at the cost of around Rs. 56,00,000/- (Fifty Six Lakhs Only), at Phuaisanphai Village, P.O & P.S- Churachandpur, Manipur, was safe & intact while paying a visit on 23/05/2023 except minor damages in the attacks of the Meitei Mob in the form of arson a few days back. It was my pleasure and Hope that my Building is and will be safe in future too.

But while paying inspection to our House on 26/09/2023 (Tuesday), after the last visit on 23/05/2023, to our utter dismay and anguish, our Building was found totally vandalised beyond redemption rendering us totally hopeless. It is highly suspected that this may be the act perpetrated by Meitei mob owing to Manipur riot.

In the light of the above fact, I humbly pray to you to kindly look into the matter and take further necessary action as per the law of the land.
