

Sir,

I, the undersigned have the honour to lay down the following few lines for your kind information and necessary actions.

That, since 2009 I and my family were temporarily residing at Zouveng, Khuga Tampak, Churachandpur at the rental house of Wahengbam Umasori Devi (42) years, D/o. Wahengbam Nabakesor Singh a parmanent resident of Kumbi Kangjeibung Mapan. On the 3rd May 2023 at around 3:00 pm a tragic ethnic crisis between Meitei and kuki started at and around the Churachandpur and burned down all the Meitei houses situated at Churachandpur during this incident my rental house and all my belonging were also burned down and leaving into ashes.

After the incident on 4th May, 2023 I and my family was deported by the Indian Army upto Kwakta Public Ground and took shelter at Kwakta Khuman Ward No. 6 Relief Camp from 5th May, 2023 but due to information laps I cannot lodge FIR in time.

Regarding the matter, I would like to request you to kindly take necessary action and lodge FIR from your kind end.
