With reference to the above cited subject, I have the honour to report to you as follows:

That, I am a Scheduled Tribe belonging to the *Vaiphei Tribe*, which is a recognized Tribe under the Constitution of India. And, I am a permanent resident of Kangvai Village, P.O., P.S.-**Churachandpur**, District- Churachandpur, Manipur.

That, on the *4<sup>th</sup> of May, 2023*, at about *1:30 PM*, a group of armed Meitei/Meitei, suspected to be members of Arambai Tenggol and Meitei Leepun attack Kangvai area and in the process the said miscreants vandalized and torched my rented house owned by Khaiboi Vaiphei (9366543955)

That, it may also be reported here that the above said criminal activities have caused grave mental agony and incurred huge loss which may be estimated to be *Rs. 7,85,000/- (Rupees Seven Lakhs Eighty-Five Thousand)* only

That, it may be reported here that the miscreants were shouting slogans like- "KANGLEIPAK YAIPHARE"; "KUKI HATLO"; "HAO HATLO"; etc. while they were carrying out their criminal activities

Therefore, I am filing this report lately as I was at Chongkhawzo Village (Thanlon, CCpur dist.) working as a daily wage/ laborer for months as I am the sole bread earner of the family, so, I humbly pray you to kindly register a FIR and investigate the matter as per the prevailing provisions of the laws of our country. And, for which act of kindness, I shall always remain thankful to you and obliged. Thus, I am filing the report lately today.
