Subject :- Report on Looting, Vandalism and burning down of house, household items/assets. And Discrimination of Schedule Tribe.

Sir,

With reference to the above cited subject I have the honour to report to you as follows :

1. That I, **Hatnu Kilong W/o (L) K C Chonsei** aged about 43 years Belonging to the **Any-Kuki Tribe / Community**, a schedule Tribe recognized under the constitution of India , by virtue of which I am being entitled to the protection under **The SC/ST (Prevention of Atrocities) Act, 1989**, and that I am a permanent Resident of **Saiton Khunou Village Churachandpur District Manipur. P.O&P.S., Churachandpur.**
2. That at about **10:30 pm** on the **3rd May 2023**, a huge contingent of armed radical meitei/Meitei suspected to be members of the Arambai Tengol and Meitei Leepun along with a mob numbering about 500 attacked our Village with sophisticated weapons. so in order to save our lives we left behind our house with all our belongings ,and in the process they have looted then burnt down the house,including all our household items and also our Granaries etc.
3. That, it may be reported here that the above said criminal activities have caused grave mental agony me and incurred huge loss which may be estimated to be **Rs. 20,00,000/- (Rupees Twenty Lakhs) only.**
4. Fortunately, I and my family managed to escaped from the criminals who even tried to kill us, and now currently taking refuge at **B Aizalon Village, Churachandpur Dist..**
5. That, I am filing this information lately because there is a great danger to my life and due to which I was at different places to save my life and now I am able to restore my health . And thus, I am filing the report lately today.

In the given circumstances, I humbly pray you kindly register an FIR, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And for which act of kindness, I shall always remain thankful to you and obliged.
