I would like to report that today i.e. 25th October, 2023 at 9:00 am, received a reliable information that a joint MVCP of Torbung Bangla had intercepted one white colour Maruti Gypsy bearing Registration No. MN07E0019 and recovered one Pistol 7.65 mm alongwith one magazine and 25 rounds from the possession of Mr. Kammin Hangshing @ Lalcha (29) years s/o Thanglam Hangshing of K. Gamnomphai Village, Saitu Gamphazol Sub-Division, Senapati, Manipur with an intention of carrying out some prejudicial activities, while carrying out joint MVCP from the general area of Torbung Bangla today i.e. 25/10/2023 at 0840hrs. Immediately I alongwith Police party of CCP-PS rushed to the spot and arrested the above individuals namely Mr. Kammin Hangshing @ Lalcha (29) years s/o Thanglam Hangshing of K. Gamnomphai Village, Saitu Gamphazol Sub-Division, Senapati Manipur and his accompany Mr. Kamminsei Kipgen @ Minsei Kipgen (23) years s/o Mangboi Kipgen of K. Gamnomphai Village, Saitu Gamphazol Sub-Division, Senapati Manipur at 9:52 & 9:55 am of today and also seized the above mentioned arms and vehicle at 10:00 am respectively. The arrested accused persons and the seized items were brought at this Police Station.
