Subject:-Request for lodging of FIR case regarding arson/damage &looting of household properties.

Sir,

I, the undersigned have the honour to state the following few lines for your kind consideration and further necessary action.

That, a large number of unidentified groups of people belonging to Kuki community with deadly weapons and sophisticated arms including Kuki militants groups stormed to all Meitei inhabited areas of Churachandpur Town on 3<sup>rd</sup> day May, 2023 at around 5:30 pm. They started destroying, looting and burning down the houses and house hold properties of Meitei community. Due to fear and panic, I along with my family left my rented house located Beaulah Lane, Churachandpur and now taking shelter at the residence of our relative located at Malom Tuliyaime Mayai Leikai, Imphal West. On 06/05/2023, it is informed by the villager who residing nearby our rented house that all the house hold properties of my rented house were damaged and other remaining valuable items has been looted in between the midnight of 3<sup>rd</sup> to 5<sup>th</sup> May, 2023 by some unknown armed miscreants suspected to be Kuki militants. The approximate value of the loss properties is Rs. Rs. 21,08,000/-rupees twenty one lakhs and eight thousand) (enclosed list of loss properties as Annexure A). I could not report well in time as I along with my family members were engaging in the medical treatment of my husband who expired in the month May, 2023 and lack of legal knowledge and displacement.
