


That Sir I am permanent resident of Phougakchao Ikhai Awang Leikai and I am Supplying Fish at Churachandpur since last 5 years.

On Date 3<sup>rd</sup> May 2023 my fish which I supply at Churachandpur is looted (43 boxes) by kuki Militant at New Bazar Churachandpur at around 2:30 pm. approximately Rs 4,33,440/-.

I could not report earlier in the tense situation and now reported when there is little normalcy in the locality but not stable.
