Sir,

I have the honour to state that received a reliable information on 09/05/2023 at about 7:00 am, on the same day at about 6:00 am (morning) my rental Godown mostly of electronic appliances located at Old Bazar near Churachandpur Police Station, Churachandpur District, Manipur own as a lend rental house and run as rental by namely Shri Gurumayum Krishno Sharma aged about 55 years S/o Shri Gurumayum Nandalal Sharma residence of Saiton Awang Leikai were looted by some unknown miscreants by breaking the Godown door shutter and carried away all the available electronic items/appliances which were kept inside my rental Godown. I immediately, went to Churachandpur at my rental Godown and after reaching there, I shown that all the available electronic items at the Godown were looted and taken away by some unknown miscreants taking the advantage of myself unavailable and amidst the unruly eruptions of ethnic clashes between Meiteis and Kukis which was broken-out since from the 3rd May, 2023. I couldn't timely report to the nearest Police Station about the incident as I was not aware properly about the report of the incident.

A separate sheet showing the particulars of the losses incurred by me is attached along with the present application.

In the above facts and circumstance, it is therefore respectfully requested that your goodself may cause the arrest of the unknown miscreants who involved looting the above cited electronic appliances and take appropriate necessary legal action against the unknown culprits accordingly to the law of the land.
