I would like to report that on 05/05/2023 at around 8:30 PM while returning home visiting relatives and following the main road Tiddim Road, I was hit by a stray bullet on my left leg just above my ankle penetrating through my leg luckily not hitting the bones, highly suspected to be fired by unknown miscreants infront of Venus Hotel, Gouchinkhup Veng, New Lamka. I was immediately rushed to District Hospital for medical treatment in which the Medical Officer on duty administered me first aid and was discharged. Complaint report could not be made on time as I under constant medical treatment at home and under trauma for a few months.

In this regard I would like to request you to kindly take up necessary legal action against the unknown miscreants at the earliest.
