Subject: Report on missing of domestic casttles due to sudden attacked by Arambai Tenggol, Meetei Leepun & unknown armed miscreants.

Sir,

With reference to the above cited subject I, the undersigned representing the villagers of Kulbung Village churachandpur would like to bring to your kind attention of the following points.

- That, Kulbung village churachandpur District was attacked by unknown armed miscreants with automatic rifles on the fateful evening of 3rd May 2023 at about 4:20 pm.
- 2. That, the Villager had been facing attacked by unknown armed miscreants twice again, so that the villagers were moved to safer location at S.Gilgal Village Tuibong near Songza khopi, Tuibong Sub-Division Ccpur due to fear from the heavily attacks and have been taking shelter.
- 3. That, during this time armed miscreants suspecting to be Arambai Tenggols & Meetei Leepuns were stationed and dominated at Gotengphai village after burning down all the nearby villages and resort to lootings and killings of our domestic animals.
- 4. That, in doing so the domestic animals (cattles) of the following villagers have either been killed or captured by the unknown armed miscreants suspected to be Arambai Tenggols & Meetei Leepuns; and tablelation details were given as under:
