It has come to light that the Joint Students' Body, Lamka Information and Publicity Wing (IPW) has released a public reminder on 26th October, 2023 stating regarding their standpoint in order to make the Government (of Central and Manipur) hear and as a form of resistance against Government of Manipur under N. Biren Singh, the Joint Students' Body, Lamka had adopted a resolution on August 10, 2023, stating that "all institutions of the Government of Manipur starting from the DCs/SPs/ZEO/ADC's office, including Government schools/colleges in the town, to observe every Friday as a holiday." This public statement obstruct public servant in discharge of public functions and wrongful restraint, threatening the public servant and also creating criminal intimidation against the Government.

Hence, a suo-moto case under FIR No.2823(10)2023 CCP-PS u/s 186/341/189/506 IPC has been registered against the members of the Joint Students' Body, Lamka for taking necessary action.
