Subject :- Report on Looting, Vandalism of house, household items/assets , and Discrimination of Schedule Tribe.

Sir,

With reference to the above cited subject I have the honour to report to you as follows :

1. That I **Rebecca Vaiphei** aged about 60 years W/o (L) **Vunglianthang Kapvung** Belonging to the **Vaiphei** Tribe / Community, a schedule Tribe recognized under the constitution of India , by virtue of which I am being entitled to the protection under **The SC/ST (Prevention of Atrocities) Act, 1989**, and that I am a permanent Resident of **Kangvai Jubilee Veng Village Churachandpur District, Manipur. P.O&P.S., Churachandpur.**
2. That at about **5:00 pm** on the **3<sup>rd</sup> of May 2023** a huge contingent of armed radical meeitei/Meitei suspected to be members of the **Arambai Tengol and Meetei Leepun** along with a Mob numbering about 1000 attacked our Village with sophisticated weapons so in order to save our lives, I and my family have to run for our lives, leaving behind our house with all our belongings . And in the process my house was partially destroyed, vandalised and then looted.
3. That, it may be reported here that the above said criminal activities have caused grave mental agony and incurred huge loss which may be estimated to be about **Rs. 3,00,000/- ( Rupees Three Lakhs) only.**
4. Fortunately, I and my family managed to escaped from the criminals who even tried to kill us, and now currently taking refuge at **Red Cross Road, Churachandpur .**
5. That, I am filing this information lately because there is a great danger to my life and due to which I was at different places ( **Aizawl**) to save my life and now I am able to restore my health and settled at The above mentioned address. And thus, I am filing the report lately today.

In the given circumstances, I humbly pray you kindly register an **FIR/ZERO FIR** , investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And , for which act of kindness, I shall always remain thankful to you and obliged.
