Subject :- Report on Looting, Vandalism of house, household items/assets , and Discrimination of Schedule Tribe.

Sir.

With reference to the above cited subject I have the honour to report to you as follows:

- 1. That I Rebeccah Vaiphei aged about 60 years W/o (L) Vunglianthang Kapvung Belonging to the Vaiphei Tribe / Community, a schedule Tribe recognized under the constitution of India, by virtue of which I am being entitled to the protection under The SC/ST (Prevention of Atrocities) Act, 1989, and that I am a permanent Resident of Kangvai Jubilee Veng Village Churachandpur District, Manipur. P.O&P.S., Churachandpur.
- 2. That at about 5:00 pm on the 3rd of May 2023 a huge contingent of armed radical meeitei/Meitei suspected to be members of the Arambai Tengol and Meetei Leepun along with a Mob numbering about 1000 attacked our Village with sophisticated weapons so in order to save our lives, I and my family have to run for our lives, leaving behind our house with all our belongings . And in the process my house was partially destroyed, vandalised and then looted.
- 3. That, it may be reported here that the above said criminal activities have caused grave mental agony and incurred huge loss which may be estimated to be about Rs. 3,00,000/- (Rupees Three Lakhs) only.
- 4. Fortunately, I and my family managed to escaped from the criminals who even tried to kill us, and now currently taking refuge at Red Cross Road, Churachandpur.
- 5. That, I am filing this information lately because there is a great danger to my life and due to which I was at different places (Aizawl) to save my life and now I am able to restore my health and settled at The above mentioned address. And thus, I am filing the report lately today.

In the given circumstances, I humbly pray you kindly register an FIR/ZERO FIR, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And, for which act of kindness, I shall always remain thankful to you and obliged.
