- That, I Mr. Haokhogin aged about 28 years, belonging to the Thadou-Kuki Tribe/Community, a schedule Tribe recognised under the ST/SC (prevention of atrocities) Act, 1989. and that, i am a permanent resident of Kulbung Village Churachandpur District, Manipur 795128.
- That, at about 6 PM on the 5th of May some heavily armed redical mobs along with Meetei
 Leepun, Arambai Tengol and State force attack and looted my house and Verities Store items which
 i buy from the money i borrow (Mudra Loan) from SBI Salbung Branch, a loss estimated to be at an
 amount of 7,00,000 (Seven Lakhs) approximately.
- Fortunately, me and my family managed to escape from this criminals and now currently taking refuge at Gilgal Village, Churachandpur.
- Due to displacement from Kulbung Village to Gilgal Village with my family including one sick infant and her mother (i.e my daughter and Wife) I couldn't file my complain in time.
