


With due respect, I, the undersigned namely Tongbram Sharat Singh S/o T. Khunjao Singh about 56 years, resident of Ngangkhalawai mamang Leikai beg to submit the following few lines for your kind consideration and necessary action.

That on 3rd may, at about 04:30 pm some unknown persons numbering about 500 belonging to Kuki community started attacking the undersigned along with family members. Therefore, the Kuki people started destroying and burning the house located at old bazar which was learned to me to razed to the ground and all the belonging and jewelries were also burned/destroyed/stolen before burning/demolished.

A separate sheet showing the particulars of all the losses incurred by me is attached along with present application.

In the above facts and circumstances, it is therefore respectfully requested that your goodself may cause the arrest of the miscreants who belongs to the kuki community involved in the burning/dismantling/damaging my properties and injuring And take up an FIR against them as soon as possible for the interest of the justice.


