

With due respect, I, the undersigned namely Moirangthem Bijoy singh, age about 58 years, resident of Zou colony, beg to submit the following few lines for your kind consideration and necessary action.

That on 3<sup>rd</sup> May, at about 9pm some unknown persons numbering about 50 belonging to kuki community started attacking the undersign. Thereafter, the Kuki people started stealing domestic animals and other items.

A separate sheet showing the particulars of all the losses incurred by me is attached along with the present application.

In the above facts and circumstances, it is therefore respectfully that your good self may cause the arrest of the miscreants who belong to the Kuki Communities involved in the stealing of properties and take-up an FIR against them as soon as possible for the interest of justices.
