






**ATTEMPTED BURGLARY AT OUR SBI ATM AT UPPER LAMKA NEAR PTC

We have been informed today i.e., 05.11.2023, by well-wishers/ neighboring local people that the shutter of the ATM located at Upper Lamka has been forcibly opened by breaking the shutter locks. On visiting the ATM Site and upon opening the shutter under police supervision, the vault door of the ATM and the ATM hook door at the top were found to be forcefully opened.
