Sir,

I am to lodge the present report that the undersigned is the President of the Umang-
Lai Kanba Apunba Lup, (UKAL), a socio-religious society registered under the Manipur
Societies Registration Act, 1989, being Regd. No. 2890 of 1979(M) and our society has
gathered information of the destruction of the place of worship of the Meetei/Meitei
Community during the present unrest and we have come across many place of worship of
the Meetei/Meitei which had been destroyed/destroyed by suspected Kuki Militants and
their followers, and proper investigation is required by registering appropriate FIR. The
