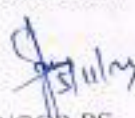

I am to lodge the present report that the undersigned is the President of the Umang-Lai Kanba Apunba Lup, (UKAL), a socio-religious society registered under the Manipur Societies Registration Act, 1989, being Regd. No: 2890 of 1979(M) and our society has gathered information of the destruction of the place of worship of the Meitei/Meitei Community during the present unrest and we have come across many place of worship of the Meitei/Meitei which had been distructed/destroyed by suspected Kuki Militants and their followers, and proper investigation is required by registering appropriate FIR.
