With reference to the above cited subject, I have the honour to report to you as follows:

That, I am the legal wife of Lamsuanmung, aged about 36 years, S/o: Chinkhansuan and we are Scheduled Tribe belonging to the *Zou Tribe*, which is a recognized Tribe under the Constitution of India and a permanent resident of Teikot Village, P.O. & P.S.- Singngat, District- Churachandpur, Manipur.

That, on the 3rd of May, 2023 at around 7:15 PM, he got shot by 2(two) stray bullets, one on his left thigh which resulted to a broken femur (thigh bone) and the other, on his right lower knee, resulted in broken Tibia, suspected to be an armed group belonging to the Meitei/Meetei community, while he was at and around the Khumujamba Leikai, P.O., P.S. & District- Churachandpur, Manipur.

That, I am filing this report lately as I was busy taking my husband to different medical camps, therefore, I request you to kindly take strong actions against the perpetrators by registering a FIR under relevant laws of our country. Thus, I am filing this report lately today.
