That, I am the brother of Th. Ginmuanlal, aged about 37 years, S/o: (L) Paudailou Simte and we are Scheduled Tribe belonging to the *Simte Tribe*, which is a recognized Tribe under the Constitution of India and a permanent resident of Simveng Village, P.O., P.S. & District-Churachandpur, Manipur.

That, on the 3rd of May, 2023 at around 10 PM, he got shot by a stray bullet on his right thigh which resulted to a broken femur (thigh bone) by an unknown miscreant as it was dark, while he was in and around the Hotel Venus area, Gouchinkhup Veng, P.O., P.S. & District- Churachandpur, Manipur.

That, I am filing this report lately as we were at Sumtuh Village, Thanlon sub-div, CCpur dist., where my brother was bedridden for months, therefore, I request you to kindly take strong actions against the perpetrators by registering a FIR under relevant laws of our country. Thus, I am filing this report lately today.
