



That, I am working as a driver by profession and was engaged in a grocery shop at New Bazar, Churachampur for transporting goods. Due to the ongoing crisis between Meitei and Kuki that broke out since the beginning of May, 2023, I along with wife could not pay visit my work place. On 09/05/2023 at about 9:00 a.m., it is learnt that some unknown miscreants suspected to Kuki Militants had damaged, set on fire and looted my properties which were inside my rented room located Meitei Youth Organisation (MYO), Khumujamba Meitei Leikai, Churachandpur in between the 3<sup>rd</sup> to 5<sup>th</sup> May, 2023. I could not report well in time due to the lack of legal knowledge. The details of the damaged/arson/looted properties are given below:


