


Subject:-Request for lodging of FIR case regarding arson/damage & looting of household properties.

Sir,

I, the undersigned have the honour to state the following few lines for your kind consideration and further necessary action.

That, I am living alone now after my husband and son had expired. On 03/05/2023 at around 6:30 pm, a large number of unidentified groups of people belonging to Kuki community with deadly weapons and sophisticated arms including Kuki militants groups stormed to all Meitei inhabited areas of Churachandpur Town. They started destroying, looting and burning down the houses and house hold properties of Meitei community at our village located at Thingkangphai, Churachandpur. In that, they caused damage, set on fire and looted the remaining valuable items of my house. Thereafter, the unknown armed miscreants warned and threatened me to leave the village permanently and if fail their direction, I will have to face serious consequences. Due to fear and panic, I left my home and now taking shelter at the residence of my younger brother namely Keisham Sobha Singh S/o (L) K. Tolhan Singh of Bamdiar Makha Leikai, Imphal West. I could not report well in time due to lack of legal knowledge and displacement.

It is, therefore, requested you to kindly take up necessary legal action against the unknown group of Kuki community and armed Kuki Militants at the earliest and requested to submit the computation of the loss to my property mentioned here, to any appropriate body of the state government to grant us the compensation that I need to rebuild my live.
