I, Most humbly like to report that my residence house located at Khugatampak Meitei Leikai, Churachandpur has been burnt down into ashes and also looted by a group of armed miscreants belonging to Kuki community numbering about 1000-2000 people on the evening of the 3rd May, 2023 at about 8:30 pm, along with gun and intend to kill all my family members.
