Sub: - Request for lodging of FIR case regarding looting and ransacking/burnt down of my rented house located at Churchandpur Khumujamba Meitei Leikai on 4th May 2023.

Sir,

I, the undersigned have the honour to state that large number of innumerable unidentified group of people belonging to Kuki Community with deadly weapons and sophisticated arms including kuki militants groups stormed to all Meitei inhabited areas of Churachandpur on 3rd May 2023 at around 4.30 pm. The said unidentified groups vandalized/burnt down my rented house and looted all valuable items including Rs. 4,00,000/- (Four Lakhs) in cash which was kept inside my godrej. In that my four wheeler vehicle Baleno bearing regd. No. MN06LB5168 was also damaged. After the said unfortunate incident/ mob violent, I was fleeing my rented house and now staying at my permanent residence, Kongpal Kongkham Leikai Imphal East District, Manipur.

It is, therefore, prayed that the respected sir may kindly initiate and take necessary legal action(s) against the persons and the persons involved in the said inhuman acts and heinous crime committed by the accused persons and persons involved as per law of the land as early as possible. I couldn't report in time as the situation happen in state.

I shall be grateful for your kind co-operation and necessary action (s).
