Sir,

I, have the honour to state that on 07/05/2023 at around 07:30 pm a large number of innumerable unidentified groups of people belongs to Kuki Community with deadly weapons and sophisticated arms including Kuki Militant Group(s) stormed at my Quarter, B1 Room No.3, DC Mini Secretariat Quarter, Tuibong, CCPur and looted all valuable items. In that unfortunate incident, I have lost a total amount of about Rs. 15 lakh approx. After the said unfortunate incident/mob violent my family fled away from the quarter and take shelter at DC Office, CCPur and later brought to Imphal escorted by some Army Convoy and after reaching Imphal, we were brought to Khuman Lampak Relief Camp.

It is, therefore, requested kindly to take up necessary legal action against the culprits/accused persons at the earliest.

I shell forever be grateful for your kind cooperation and necessary action(s).

Statement of Athokpam(N) Samurailatpam (O) Shantibala Devi aged about 54 yrs W/O (L) Sh. Priyobarta Sharma of Thangmeiband Lourung Pural Leikai is recorded in c/w FIR No. 448(05)29023 IPS U/S 147/148/380/392/427/436/120-B IPC CrPC is recorded on a separate sheet U/S 161 CrPC.

I was born and brought up at Thangmeiband Hijam Leikai. I was married to one Shamurailatpam Priyobarta Sharma and we have 2(two) sons and 1(one) daughter. As I was selected as Women Home Guard in the 2nd week of August, 2022 and posted at CCPUR district. On 22nd August 2004, I joined at Churachandpur DC Office as a security personnel as I was detailed at the said office and a quarter was given to me at B1 Room No. 3 allotted in my name at DC Mini Secretariat Quarter, Tuibong, CCPUR. Till the day of incident I was still staying at the quarter with my nephew namely, Khomdram Roshan Singh aged about 28 yrs S/O (L) Kh. Kuleshwor Singh of Khundrakpam Mayai Leikai as he was working as a Data entry operator of NHIDCL Authority Engineer at Gangpimoul, CCPUR as my husband was expired in the year 2012.

That on 07/05/2023 @ 7:30 pm I was cooking our dinner at my quarter, I heard some noises around my quarter. Then I ran at the terrace and look towards the direction where the noises is coming and saw some unknown Kuki individuals including Kuki Militant holding deadly weapons and arms stormed at Tuibong Bazar area and started to set fire on Meiteis houses and household things. On seeing the view I along with my nephew ran downstairs but when we reach downstairs some unknown Kukis started to throw stones at my quarter. I was feeling scary at that time and call at the office of MPR, CCPUR and narrated the whole incident and asked them to sent some police personnel to help us but I was told that there is no police personnel left at that time as they have been deployed all the personnel for duty and further asked me to run and hide at CCPUR/SP quarter which was also near to my allotted quarter. Then I along with my nephew ran from the backdoor of my quarter towards SP/CCPUR quarter leaving all our belongings at my quarter. When I reached at the place with my nephew I told the security personnel of SP CCPUR that I have left all the above mentioned items and also a four wheeler Chevrolet Spark (Parrot Green in colour) and a 2(two) wheeler Activa 3G (Marron in colour). After that the security personnel call SP from his mobile number and told the whole story. Then after the phone was hang up the security personnel told us that 2(two) of them will come with us to bring our things from my quarter. As I was feeling scary I told my nephew to go along with the security personnel at my quarter and bring some valuable items. After few minutes later my nephew and the 2(two) police personnel return driving the 2(two) wheeler Activa and the 4(four) wheeler and parked inside the campus of SP/ CCPur quarter. Further they told me that the household items, clothes valuable items like, gold ornaments, TV, Refrigerator, Washing machin etc were burnt by the Kuki's on the courtyard of my quarter. After hearing the news I cried and I was consoled by my nephew to stop crying and the list of my properties that were burnt or vandalized by the Kuki individuals that attacked us on the night are as follows.

That night we stay the night inside the four wheeler vehicle which was parked inside the campus of Sp/CCPur quarter.

On being asked I stated that, next day @ 6:00 am we were escorted by SP/CCPur security personnel to DC Office, Churachandpur where more that 400 Meiteis were taking shelter inside the campus from the Kuki Militants. At around 11:30 am all the individuals who were taking shelter at DC Office, CCPur were brought to Imphal escorted by some Army Convoy and after reaching Imphal we were further brought to Khuman Lampak Relief Camp.
