No. 2890 of 1979(M) and our society has gathered information of the destruction of the place of worship of the Meetei/Meitei Community during the present unrest and we have come across many place of worship of the Meetei/Meitei which had been distructed/destroyed by suspected Kuki Militants and their followers, and proper investigation is required by registering appropriate FIR.
