It has come to light in some social media platforms that Mr. Muan Tombing, General Secretary, Indigenous Tribals Leaders' Forum (ITLF) in an interview stated that the Indigenous Tribals Leaders' Forum (ITLF) is prepared to launch self rule in Kuki-Zo inhabited areas whether recognised by the Centre Government or not if their demand for Seperate Administration from Manipur Government is neglected within two weeks time.

The words uttered by Mr. Muan Tombing tantamounts to conspiracy to wage war or attempting to wage war or abetting waging of war against the Government of India, wantonly giving provocation with intent to cause riot and also brings or attempts to bring into hatred or contempt, or excites or attempt to excite disaffection towards the Government established by law in India.

Hence a Suo moto case under FIR No. 2938(11)2023 CCP-PS u/s 121-A/124-A/153/120-B IPC has been registered against Muan Tombing for investigation.
