Sir,

As endorsed, I have enquired into the complaint against Mr. Maheshwar Thounaojam, National Secretary of the Republican Party of India (RPI Ath) by Mr. Worthson Samuel Guite (29) yrs s/o Klupton Guite of Gangpimol dated 22nd October 2023 to this PS and based on the Tom TV News bulletin 18 Aug 2023 at 9:15 pm, Elite News bulletin date 21 July 2023 at 5:20 pm, and various videos submitted by the complainant which is available on a public domain such as Youtube and Facebook page of the accused <https://fb.watch/ootVxm7Zwd/>, the following observation has been found against the accused:

- 1) Mr. Maheshwar Thounaojam during various public meetings and interviews with the state/national media deliberately used the term "Chin-Kuki Narco terrorists" without any legal justification but to defame the Kuki tribe as "Narco-Terrorist" which cannot be suffixed/labeled to a particular community.
- 2) He further stated that "the Chin Kuki people were the only perpetrators of the present communal violence in Manipur and it's not time for the Meitei community to appease one another for communal harmony but to come together, to act and punish those demanding separate administration by treating them as a National threat" which is provocative and be taken as a call for war against the minority tribe in Manipur i.e. Kuki-Zo community.
- 3) He propagated wrong information stating that many Meitei girls were raped in Churachandpur, which is misleading and sowing seeds for hatred between the Meitei community and the Kuki-Zo community. This kind of statement was purportedly made on various occasions to justify the actions of the Meitei community in the valley such as gang rape.

Such an irresponsible statement/proclamation/speech in public meetings/gatherings from a prominent politician such as Mr. Maheshwar Thounaojam with a huge public following/support has the potential to incite violence, mislead the public, and humiliate the scheduled tribe community. Prima facie evidence is well established against Mr. Maheshwar Thounaojam for the registration of an FIR for investigation.

Hence, the report is submitted for favour of kind perusal and further n/a, please.
