I the undersigned would like to report that my husband had been serving as an assistant teacher in Green Wood Academy, B. Vengnoum, Tuibong, Churachandpur for the last 13 (thirteen) years and had stayed along with my husband and 3 (three) children inside the school campus. Due to the ongoing conflict started since 3rd May 2023, we left our household materials which had been guarded by the school authorities till 2nd week of September 2023. But now we received a telephonic information from school authority on 15/09/2023 at around 2.30 pm, that some unknown militant and Kuki civilian persons had looted all our household materials approximately worth about Rs. 3,50,000 (three lakhs fifty thousand) from our residence (School Quarter).

My husband couldn't report well in time as he is going to another state for earning money for livelihood. So, I am and on behalf of his wife like to report to your kind office for the justice:

It is therefore, I am requested you to kindly take up necessary legal action against the said kuki militant and kuki civilian persons.
