Respected Sir,

I, the undersigned beg to report for you kind and necessary action.

1. That, I and my family members were residing at Bol-jol Village, Churachandpur, Aizawl  
P.O. Teribong P.S. Churachandpur DIST. Churachandpur Manipur for opening a  
tailor shop. My family was there for the last 4/5 years. We are the victims of the present  
unrest the occurred from 03-05-2023 onwards. Now we are moving from one place to another for  
living. Delay of filling a F.I.R is due to displacement and uncertainty of relief camp/place.

2. That, on 03/05/2023 at around 7.30 a.m./p.m., while I was at my residence along  
with my family members consisting of myself, my husband/wife, children and other family member,  
some unknown armed miscreants attacked my house, physically assaulted my family members  
including myself and destroyed household properties worth around  
Rs. 4,69,000 (Rupees Four Lakh Sixty Three Thousand only) approximately.

3. That the unknown miscreants are suspected to be the kuki tribe as they conversed among  
Themselves in the kuki dialect while firing and assaulting my family and destroying my household  
Properties. The list of family members and damaged properties are enclosed with this report.

4. That, the unknown armed miscreants warned and threatened my family members and myself to  
leave the village permanently and that we will face dire consequences if we return to our village again.

In view of the facts and circumstances, I shall be very grateful if you good self would kindly initiate  
Appropriate steps for identifying the unknown arms miscreants, apprehend them and punish them in  
accordance with law.




