Sub: Report.

Sir,

I the undersigned would like to report to you that, on 19/11/2023 at around 11:00 pm one person contacted me in my Instagram account (Jamboboi99) who is having profile name as Aarti Sharma having Profile link: <https://instagram.com/aarti9883sharma?igshid=NGVhN2U2NjQ0Yg==> stating that she is from Jaipur, Rajasthan, India. We both chatted for a few hours and she asked me for my Whatsapp number. I sent my whatsapp number 8787569968 through her Instagram account thinking that she was friendly.

Later, on the same night at around 11:40 pm she contacted me with her Mobile No. 9509742489 through whatsapp. After chatting for a few minutes she made a video call through whatsapp wherein she asked for online video sex. I agreed to her request and we made video call through whatsapp for about 1 minute thinking that she will not create any harm or issues to violate my privacy.

On the next day i.e. 20/11/23 at around 11:25 am she send me the video record through my whatsapp number and threaten me to pay an amount of Rs. 9,200/- without which the video recording will be made public or gone viral in social media. Due to fear that the video recording will be made viral I paid Rs. 9200/- through my Paytm Account: Ngamkhojam Haokip, UPI Id: 8787569968@paytm, State Bank of India - 5007 to her Gpay Account No. 9257399369 as per her demand.

To my surprise I was then contacted again and she again demanded me to pay another amount of Rs. 16,499/- stating that the amount was for Instagram stop charge. As of now, I refused to pay her the second demand amount as I feel victim's in her trap.

Therefore, I requested your good office to kindly look into the matter in identifying the culprit(s) and recovering my money and to take legal action as per relevant section of law.
