Dear Sir,

We are writing to bring to your attention a serious matter concerning the theft of pipes and other project items from the **Lamka College Site** in Manipur meant for NDB Water supply project as referenced above being undertaken in Churachandpur districts. As an involved party in this project, We feel compelled to report this incident and request a prompt investigation.

The theft occurred between dated:03.05.2023 to 31.07.2023 since the onset of the recent ethnic clashes in the state and was discovered during routine site inspections. Several pipes and crucial project materials were found to be missing, which not only poses a significant setback to the project timeline but also raises concerns about the security measures in place at the site.

We would like to urge the department to take immediate action to address this issue. It is crucial that a thorough investigation is conducted to identify the individuals responsible for this theft. Additionally, steps should be taken to enhance security measures on the site to prevent any future occurrences.

The stolen items include **Scaffolding pipe, Clamps, U-Jack, Prop jack, BOSCH Grinder machine, BOSCH PRO Metal Cut Off, Steel full length of various sizes, Spade & Shovels, sand, cement, aggregate** etc and their absence is causing disruptions to the project schedule. We request that appropriate measures be taken to recover the stolen items and ensure the responsible parties are held accountable.

We believe that addressing this matter promptly will not only safeguard the interests of all stakeholders involved in this public project but also reinforce the importance of maintaining a secure and productive work environment for such project of public importance.

We appreciate your attention to this matter and trust that appropriate actions will be taken to address the situation.
