


Subject: - Request to register a regular FIR against H. Dingo Singh.

Sir,

With due respect, I would like to state a few lines for your kind perusal and necessary action please.

1. That, Mr. Dingo Singh, is an elected people's representative (Member of Legislative Assembly) of Sekmai Assembly Constituency.
2. A video clip has been circulating in some social media platforms in which Mr. Dingo Singh, MLA of Sekmai A/C made a public statement during the "Youth Convention program" at Sekmai Assembly Constituency held on the 14-10-2023, Wherein, he explicitly and deliberately made a statement proclaiming the entire Kuki-community as "Narco-Terrorist". This is completely baseless and derogatory in nature.
3. That, he being an elected member of Manipur Legislative Assembly (MLA) having sound mind, ethical and professionalism, making biased and unverified exclamation towards a particular community by terming as Narco-Terrorist, at this peak hour of volatile and strife torn state of Manipur is uncalled for. Such accusation made therein without having either any reasonable classification as guaranteed by Article 14 or legal justification and sanctity infringed right in rem of the Kuki Community at large.
4. During his speech, he further made accusation with ulterior motive; coined such defamatory and concocted allegation against a particular community branding as Narco-Terrorist for his own personal and political gains. Simultaneously, abetted and co-conspire with the ideology and intention in consonance with the Radical groups such as Arambai Tenggol and Meitei Leepun.

5. Such act of appeasement policy adopted by him, in appeasing many youth who were present with fatigue or arm clad during the Youth Convention is by far a misleading and a public mischief. Therefore, it could be seen promptly that prima facie material is well established from his speech and statement by inciting the youth present therein, provoked them to instill to pacify his personal and political gains through hatred campaign.
6. Simultaneously, to encourage the youth to continue their fights against a particular community i.e. Kuki People and to strive to annihilate the entire community from the present state of Manipur. Hence, such statement made therein is pure evil intention to create a false propaganda and demonized one community upon another one.
7. His statement create diversion, subversive, enmity and could derailed the peace which is highly in need of time, to heal the wounds of the ethnic cleansing perpetrated by the Arambai Tenggol and Meitei Leepun for their own political and social justification.
8. Thus, his statement made therein is by far a clear intention with malice to maligned and create incitement to youth in perpetrating crime against the particular community i.e. Kuki Community. Similarly, an atrocity committed against Schedule Tribe under Section 3(1)(v) of SC/ST (Prevention of Atrocities) Act 1989. As well attracted Sec. 153/153A/ 500, 505/506/506A/34 IPC
