Sir,



I am to report that i lived in a rented house of one Laishram Chandrahash Singh (75) of Mandop Leikai, Churachandpur District for the last 30 years and run poultry and piggery farm there.

That self and my family members are victims of the present unrest that outbreaks from 3<sup>rd</sup> May, 2023.

That on 3<sup>rd</sup> May, 2023 at around 4.20 pm, a huge mob numbering around 200 to 300 unknown people armed with deadly weapons , suspected to be armed kuki militants stormed at my rented house and Shop had been vandalised and all the properties kept inside it were looted after breaking the lock and key of the Store and also burnt down by unknown miscreants suspected to be Kuki militants. Self along with my family members run towards DC Complex, Churachandpur. The approximate amount of the damaged and looted items is worth around Rs. 13,62,000/-(Thirteen Lakhs Sixty two thousand ) ony.

I could not report well in time as I was stranded and displaced. After that I took shelter at a relief Camp at Moirang Yumkhaibam, Bishnupur District. And further self was attending to the treatment of my younger brother at JNIMS, Imphal. At present we are staying at one of the Quarters at DDK Imphal, porompat

It is therefore, requested kindly ot take up necessary action against the ay of the Store of unknown miscreants suspected to be of Kuki militants. hiteants in felong
