Sir,

I am to report that I had been lived in a rented house of one Lalshram Ningthouren Singh of P. Kamdou veng, Tuibong, Churachandpur District for the last 33 years and run a poultry and piggery farm there.

That self and my family members are victims of the present unrest that outbreaks from 3rd May, 2023.

That on 4th May, 2023 at around 4.20 pm while I was at Leimatak village, Churachandpur, I received a phone call from one of my elder brother namely M. Romesh Singh stating that my rented house had been vandalised and all the properties inside it were looted after breaking the lock & key of the store and also burned down by unknown miscreants suspected to be kuki militants. The approximate amount of the damaged & looted items is worth around Rs. 3,62,000/- (rupees Three Lakhs & Sixty two thousands) only in the present market. And I could not report well in time due to fear of general public in the prevailing law and order situation in the state of Manipur.

It is therefore, requested kindly to take up necessary action against the unknown miscreants suspected to be of kuki militants.
