Subject:- Request for lodging of FIR case regarding looting and ransacking/damaged of my properties located at Churachandpur Bijang Lourup in between 15th and 20th May 2023.

Sir,

I, the undersigned have the honour to lay down the following few line for your kind perusal and further necessary action please, that I have lease a building comprising of 6(six) rooms with compound located at Bijang Lourup, Churachandpur District, Manipur from the land owner namely Mrs. Nengkhokim Haokip aged about 58 years W/O. Lunminthang Haokip of En-El Lhangkim Village M Chanou Moreh, Chandel on 5th October, 2020 by depositing a sum of Rs. 4,00,000/- as surety with Rs. 40,000/- as monthly rent fees to the owner. Further, I have used the said building as shop namely "WEDO SHOP" and running from December, 2020. In this shop, many gift items, ladies accessories, cosmetics, shoes, cloths, jewellery items, Cutlery items, stationary items, house hold items, carpet etc. import from Korea were sold. But, in between 15th and 20th May 2023 large number of innumerable unidentified groups of people belonging to Kuki community with deadly weapons stormed at my shop and looted all valuable items and vandalised/damaged all the furniture items and others inside the shop. In that unfortunate incident, approximate amount of my lost properties is Rs. 80,00,000/- (Rupees eighty lakh) only.

It is, therefore, requested you to take up necessary legal action against those accused persons for such inhuman acts committed by them as per law.

- b, That, the period of Lease has been started with effect from the day above mentioned for a period of 11 months and renewable thereafter with the mutual consent of both parties.
- c, That, the Lessee agrees with the Lessor that a sum of Rs. 40,000/- only is fixed as monthly rent of the Lease premise which is payable on or before 10th of every English Calendar month.
- d, That, the Lessee has also agreed with the Lessor that Lessee has the right to enjoy the Lease premise during the subsistence of the Lease period without any disturbance by the Lessor.
- e, The Lessee shall deposit a sum of Rs 4,00,000/- (Four Lakh only) as security deposit to the Lessor which is refundable after the completion of the period of Lease.
- f, At the times during the term of the lease the Lessee agreed to keep and maintain the premises clean, tidy, healthy, wind and watertight in all seasons and further in good and substantial repair.
- g, To permit the LESSOR, his servants and agents at all reasonable hours to enter into the property to inspect the condition or to leave notice of all defects to be repaired.
- h, That the Lessee shall entitle to raise the wooden/steel Rack/construction of temporary nature in the PLOT. The Lessee shall remove the aforesaid RACK at the time of vacating the premises at his own cost.
