


With due respect I would like to report that on 3rd May 2023 @ 9:00 pm a large unknown gathering suspected to be Kuki miscreants/Kuki Militants with fully armed sophisticated weapon attacked my residential house located at Zoveng Khuga Tampak and one Grocery shop residing at Old Zehang Bazar, PO & PS - Churachandpur and the said armed miscreants set on fire and looted/destroyed my household items and Grocery items. List of the damaged/burnt properties are given below.
