





With due respect I would like to report that on 3rd May 2023 @ 9:00 pm a large unknown gathering suspected to be Kuki miscreants/Kuki Militants with fully armed sophisticated weapon attacked my residential Rent house located at Zoveng Khuga Tampak, PO & PS - Churachandpur and the said armed miscreants set on fire and looted/destroyed my household items. List of the damaged/burnt properties are given below.

That, the assets/properties damaged/looted was estimated around Rs. 4,82,500 (Four lakhs Eighty two thousands and five hundred). Due to the incident, I along with my family members fled from my rent house to save our life and now, taking shelter at Kumbi College Girl Hostel Relief Camp. Delay of filing this report is due to displace and present law & order situation.

In this regard I would request you to kindly take necessary legal action against the person involved according to law at the earliest.
