a victim of the communal unrest in the state.

started, I was forced to leave the place on 04/05/20
morning and presently taking shelter at Moirang
Sinihon at the farm house of Maikam Bunge
Singh. After leaving my rented house, it is
learnt that my rented house along with Rs. 8
Lakhs as cash money, 20 bags of rice, 8 sa
of gold, fire woods and other properties in
the house were stolen, damaged and later
burnt to ashes. It is requested to kindly
register a case against the perpetrators.
