Dear Sir,

I am writing to bring to your urgent attention a grievous matter concerning the disappearance of an Excavator on November 30, 2023 around 6:30 pm. The Excavator was transporting by a trailer bearing registration no. NL01AD2654, to a new construction site in Arunachal Pradesh after successfully completing work for BIPL at Churachandpur.

The unfortunate incident occurred near District Hospital Churachandpur, where the Excavator was snatched by 2 to 3 unknown individuals. During this appalling incident, our staff member, Neilalung Pamei (contact no. 8179659649), along with the trailer's driver and co-driver, were subjected to physical assault. Subsequently, they were forcibly removed from the premises. Since this distressing event, all efforts to locate the whereabouts of the machinery have been in vain.

The sudden and forceful nature of this incident has left us deeply concerned about the safety of our equipment and the welfare of our staff. Therefore, I humbly request your immediate intervention and necessary actions to help recover the missing Excavator. Any assistance or investigation from your esteemed department to retrieve the stolen machinery would be highly appreciated.

Enclosed with this letter, you will find the necessary documentation regarding the Excavator, including its registration details and the formal complaint registered with the concerned authorities.

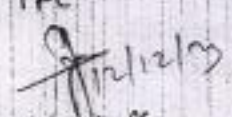
