With reference to SP-CCP Orders No. C-12/2/SP-CCP/2023/5559 dated 28/11/2023 a combine team of Singngat Police, SDO/SDM-SGT, Forest Dept. and 46 AR with Churachandpur District Police led by DSP-CCP, under the supervision of SP-CCP were detail to carried out destruction of illicit opium poppy cultivation at Mongjang village area under Singngat Police Station on 01/12/2023. There, SDO/SDM-SGT furnish attachment and destruction order of the illicit poppy cultivation in the said area u/s 48 of ND&PS Act 1985, as amended.

The combine team proceeded from Singngat PS at 9:00 am and reach at Mongjang village hill rang at around 11:30 am of the day. The area of illicit poppy cultivation along the ridge and hills slopes. The area of the land was measured and found to be approximately 02 Acres. The cultivation was on the top and slops of the ridge and cultivated far away from the view of the people

around the area. No one came forward to claim the ownership of the cultivation.

Then, we examine the plant systematically and confirmed that the same was opium poppy plants. On closure examination it was found that in a 1/1 meter area there were about 10 plants approximately of 3/5 inch tall. Hence, five poppy plants, about 3/5 inch tall have been seized in presence of witness. Then the illicit poppy were cut down/uprooted and burned as per provision of Law the destructed area is expected to yield about 5kgs of opium. Detail of the photography befor, during and after destruction were taken for adducing evidence if required in the court of the law. Therefore, a suo-moto case is registered for further investigation.

This report is treated as an OE of FIR No. 50(12) 2023 SGT-PS u/s 18 ND&PS Act.
